All puppies receive a vet exam prior to leaving and are issued a health certificate for their flight if being transported by air. If for some reason you are concerned with the health of the puppy, you may wish to take the puppy (at your expense) to a vet of your choice to ease your concerns. If a refund is requested for the said puppy, due to a vet verified health condition, it must be done within 3 working days of receipt of the puppy. In addition, we guarantee the described puppy against any inheritable/genetic defects that would take the puppy's life for a period of 24 months. Should a licensed veterinarian determine that such genetic defects are present during this time frame, Wiggle Rump Ranch will offer a replacement puppy of equal value or a refund of puppy's original purchase price once we have had a veterinarian of our choice evaluate the puppy/dog in question.

In purchasing a guardian program puppy from Wiggle Rump Ranch (Monica Rinehart), you are agreeing to allow seller to retain all breeding; rights/expense responsibility (showing if applicable, health testing, breeding, whelping, rearing of puppies). Breeder will be the AKC paper holder unless buyer wishes to enter AKC conformation and/or performance events at their own expense, then a co-ownership can take place.

Breeder/seller must give written permission to spay/neuter dog prior to any alteration of this animal. There is a \$5000 penalty if spay/neutered without written consent.

**Under No Circumstances should a Wiggle Rump Puppy/Dog end up in a pet shop, research lab, shelter, or similar facility.**

In purchasing a puppy from Wiggle Rump Ranch, you are agreeing to keep the puppy/dog at home living with you. If at any time in the dog's life you are unable to keep and/or care for the dog, you agree to contact us FIRST and return the dog immediately if requested. We may have a suitable home waiting and will always assist with rehoming if needed. This contract is not transferable.

**Our Main Concern is for the Well Being of The Said Puppy.**

In purchasing a puppy from Wiggle Rump Ranch, you are agreeing to maintain the puppy in good mental and physical condition. If either Buyer or Seller takes any legal actions regarding this contract, actions are to be initiated in Kittitas County, Washington.

**Additional Care Instructions:**

**No Jogging, Jumping, Intense Exercise is to be asked of the puppy prior to 1 year of age and/or when growth plates have closed. Puppies will play and that is fine, but if we are asking/letting them jump off a tall deck, catch a frisbee in the air, or jog along side us, etc... - it is us pushing the puppy beyond what is safe for correct bone/joints, soft tissue, and muscle development. There will be plenty of time for these things after your puppy is done growing. Your puppy will do more than it should in an effort to please you and have fun. We must be careful as owners of such a smart, eager to please breed. :o)**

**PLEASE DO NOT OVER FEED YOUR PUPPY/DOG!**

**Obesity is so detrimental to growth/development of your puppies body. An obese dog will encounter many more health complications than a thinner one at any point of its' life.**

**Additionally we ask that you feed Life's Abundance Puppy Food for the first 6-12 months, then Life's Abundance Regular dog food. We trust the quality of the ingredients, the freshness to guarantee those ingredients are intact, and the company has NEVER had a recall. We will help you get set up to have this food delivered fresh to your door as needed PRIOR to your puppy coming home.**

## **Additional Guardian Guidelines :(REQUIRED)**

- \* Breeder is allowed to take guardian dog for necessary health screens as needed.**
- \* Breeder is allowed to have guardian dog shown by herself/family, or a trusted professional handler, with an initial warm-up/relationship building period. Shows near guardian family will be the priority to minimize time away. (ringside/day of can be an option once relationship is established)**
- \* Breeder is allowed to take guardian dog to her home for a breeding with her females at no charge to her. This is generally a 3 day stay.**
- \*Breeder is allowed to take guardian dog to a reproductive vet for a semen collection if needed for use of artificial insemination or collections for frozen storage.**
- \*Penalty clause above, page 1, if guardian animal is spayed or neutered without written consent, \$5000/**
- \*Penalty clause for guardian family using dog for breeding not directed by the breeder/seller, \$5000 or \$10,000 fine if used to make mix breed, example: doodles. These types of use of our purposely bred animals are breach of our ethics we agree to uphold in maintaining good standings with our registering body AKC, Parent Club MASCUSA, and our peers and mentees.**
